3301-38-01 DEFINITIONS.

- (A) "COUNTY SCHOOL DISTRICT" MEANS THE TERRITORY WITHIN THE TERRITORIAL LIMITS OF A COUNTY, EXCLUSIVE OF THE TERRITORY EMBRACED IN ANY CITY SCHOOL DISTRICT OR EXEMPTED VILLAGE SCHOOL DISTRICT, AND EXCLUDING THE TERRITORY DETACHED THEREFROM FOR SCHOOL PURPOSES AND INCLUDING THE TERRITORY ATTACHED THERETO FOR SCHOOL PURPOSES.

- (B) "COUNTY BOARD OF EDUCATION" MEANS THE BOARD OF EDUCATION WHICH CONSISTS OF FIVE MEMBERS WHO ARE RESIDENT ELECTORS OF THE COUNTY SCHOOL DISTRICT AS PROVIDED BY SECTION 3313.01 OF THE REVISED CODE.

- (C) "COUNTY SCHOOL DISTRICT OFFICE OF EDUCATION" MEANS THE STAFF AND FACILITIES OF THE COUNTY BOARD OF EDUCATION FOR THE PURPOSE OF PROVIDING EDUCATIONAL SERVICES.

- * (D) "COUNTY SCHOOL DISTRICT PLAN" MEANS A WRITTEN DOCUMENT APPROVED BY THE COUNTY BOARD OF EDUCATION AND THE STATE BOARD OF EDUCATION WHICH STATES HOW THE RESPONSIBILITIES OF THE COUNTY SCHOOL DISTRICT SHALL BE IMPLEMENTED AND WHICH DETAILS THE SCOPE OF SERVICES TO BE PROVIDED TO THE MEMBER SCHOOL DISTRICTS OF THE COUNTY SCHOOL DISTRICT AND/OR AGENCIES, AS WELL AS TO CONTRACT DISTRICTS. THE PLAN SHALL BE DEVELOPED IN COOPERATION WITH THE APPROPRIATE PERSONS OF THE DISTRICTS SERVED AND SHALL CONTAIN THE ELEMENTS REQUIRED IN THE RULES IN THIS CHAPTER.

3301-38-02 PROGRAM.

- (A) A STATEMENT OF PHILOSOPHY SHALL BE ADOPTED BY THE COUNTY BOARD OF EDUCATION.
- † (B) THE MISSION OF THE COUNTY SCHOOL DISTRICT SHALL BE DETERMINED BY THE COUNTY BOARD OF EDUCATION IN A POLICY STATEMENT AND SHALL BE PROMULGATED THROUGH THE COUNTY SCHOOL DISTRICT PLAN.
- † (C) THE MISSION STATEMENT SHALL BE BASED ON THE FOLLOWING PRINCIPLES:
 - (1) PROVISION OF LEADERSHIP AND SERVICE TO MEET THE INDIVIDUAL AND COLLECTIVE NEEDS OF THE DISTRICTS SERVED;
 - (2) PROMOTION OF COST-EFFECTIVE EDUCATIONAL PROGRAMS THAT ARE RESPONSIVE TO THE CURRENT AND FUTURE SOCIAL AND ECONOMIC TRENDS;
 - (3) ESTABLISHMENT OF THE COUNTY SCHOOL DISTRICT AS AN INTEGRAL PART OF THE EDUCATION NETWORK;
 - (4) LINK BETWEEN THE LOCAL SCHOOL DISTRICT AND THE OHIO DEPARTMENT OF EDUCATION;
 - (5) RESPONSIBILITY OF MONITORING CHAPTER 3301-35 OF THE ADMINISTRATIVE CODE, THE MINIMUM STANDARDS FOR ELEMENTARY AND SECONDARY SCHOOLS; AND
 - (6) IMPLEMENTATION OF SERVICES AS REQUIRED BY THE REVISED CODE, THE COUNTY BOARD OF EDUCATION, OR REQUESTED BY THE OHIO DEPARTMENT OF EDUCATION.

3301-38-03 FACILITIES.

THE COUNTY SCHOOL DISTRICT PLAN SHALL ADDRESS THE PROVISION OF PHYSICAL FACILITIES CONSISTENT WITH THE MISSION STATEMENT, THE SERVICES PROVIDED, AND THE REQUIRED STAFF IN ACCORDANCE WITH ADOPTED POLICIES WHICH COVER THE FOLLOWING:

- (A) FACILITIES SHALL BE OF QUALITY AND QUANTITY TO SUPPORT STAFF.
- (B) FACILITIES SHALL:
 - (1) INCLUDE WORK SPACE, PROFESSIONAL LIBRARY, FILING FACILITIES, ACCESS TO TELEPHONES, PRIVATE CONFERENCE SPACE, PRIVATE RESTROOMS, AND ADEQUATE PARKING WITH EASY ACCESS FOR LOADING AND UNLOADING;
 - (2) HAVE A MEETING ROOM TO ACCOMMODATE COUNTY BOARD OF EDUCATION MEETINGS AND OTHER ASSEMBLIES IN ACCORDANCE WITH SECTION 3319.19 OF THE REVISED CODE; AND
 - (3) BE ADEQUATELY EQUIPPED.
- (C) FACILITIES AND GROUNDS SHALL BE WELL MAINTAINED AND FREE FROM HAZARDS AND IN COMPLIANCE WITH FIRE AND SAFETY LAWS AND REGULATIONS AS EVIDENCED BY REPORTS OF REQUIRED FIRE AND HEALTH INSPECTIONS BY THE APPROPRIATE LOCAL AUTHORITY.
- (D) PHYSICAL FACILITIES SHALL BE EVALUATED ACCORDING TO THE FOLLOWING CRITERIA:
 - (1) THE EVALUATION SHALL BE CONDUCTED ACCORDING TO PROFESSIONALLY RECOGNIZED CRITERIA AND PROCEDURES;
 - (2) THE PHYSICAL FACILITIES SHALL BE IN COMPLIANCE WITH PUB. L. 94-142 AND SECTION 504 OF THE REHABILITATION ACT OF 1973; AND
- (E) THE COUNTY COMMISSIONERS OR THEIR EQUIVALENT GOVERNMENTAL BODY HAVE RESPONSIBILITY TO PROVIDE AND EQUIP FACILITIES IN ACCORDANCE WITH SECTION 3319.19 OF THE REVISED CODE. A MEETING SHALL BE INITIATED BY THE OHIO DEPARTMENT OF EDUCATION WITH THE COUNTY PROSECUTOR AND THE COUNTY COMMISSIONERS WITHIN FORTY-FIVE DAYS OF RECEIPT OF THE EVALUATION TO REVIEW THE FINDINGS. A PLAN TO CORRECT ANY EXISTING DEFICIENCIES SHALL BE DEVELOPED. THE RESULTS OF THE PLAN SHALL BE SUBMITTED IN WRITING AND SHARED WITH ALL PARTIES.

3301-38-04 FISCAL MONITORING.

THE COUNTY SCHOOL DISTRICT PLAN SHALL PRESCRIBE THE ROLE OF THE COUNTY SCHOOL DISTRICT OFFICE OF EDUCATION IN THE FISCAL MONITORING OF THE LOCAL SCHOOL DISTRICTS. THE PLAN SHALL INCORPORATE THE FOLLOWING:

- (A) CONSULTATION AND REVIEW BY THE COUNTY SUPERINTENDENT REGARDING THE LOCAL BUDGET DOCUMENT, APPROPRIATION MEASURE, SCHOOL DISTRICT TAX LEVY, AND LOCAL BOND ISSUES PRIOR TO ADOPTION;
- (B) ACCESS TO ALL COMPLETED OHIO DEPARTMENT OF EDUCATION FISCAL MANAGEMENT INFORMATION;
- (C) CONSULTATION WITH THE OHIO DEPARTMENT OF EDUCATION ON FISCAL MATTERS PERTAINING TO THE LOCAL SCHOOL DISTRICTS, INCLUDING REQUESTS FOR STAFFING AND FINANCIAL ANALYSIS AND INVOLVEMENT IN THE EMERGENCY SCHOOL ADVANCEMENT FUND PROCESS;
- D^o (D) EVIDENCE THAT SELECTED SERVICE(S) HAVE BEEN SUBJECTED TO A COST-BENEFIT ANALYSIS TO DETERMINE IF SERVICE(S) ARE BEST PROVIDED BY INDIVIDUAL SCHOOL DISTRICTS OR BY COOPERATIVE ARRANGEMENTS BETWEEN/AMONG THE DISTRICTS; AND
- (E) EQUITABLE DIVISION OF FUNDS BETWEEN THE DISTRICTS INVOLVED WHEN A COUNTY BOARD OF EDUCATION CREATES A NEW LOCAL SCHOOL DISTRICT FROM ONE OR MORE DISTRICTS OR PARTS THEREOF AND WHEN A COUNTY BOARD OF EDUCATION TRANSFERS A PART OF A SCHOOL DISTRICT TO AN ADJOINING SCHOOL DISTRICT IN ACCORDANCE WITH SECTION 3311.22, 3311.231, OR 3311.26 OF THE REVISED CODE.

3301-38-05 PERSONNEL IN THE COUNTY OFFICE OF EDUCATION.

THE COUNTY SCHOOL DISTRICT PLAN FOR COUNTY OFFICE OF EDUCATION PERSONNEL SHALL INCLUDE POLICIES AND PROCEDURES TO ENSURE THAT THE

- (A) COUNTY OFFICE OF EDUCATION PROVIDES SUPERVISORY SERVICES TO LOCAL SCHOOL DISTRICTS IN ACCORDANCE WITH SECTION 3317.11 OF REVISED CODE;
- (B) STAFF IS ADEQUATE IN ORDER TO IMPLEMENT ITS MISSION;
- (C) STAFF SHALL POSSESS THE QUALIFICATIONS OF PREPARATION, EXPERIENCE, AND ATTITUDE TO CARRY OUT THE MISSION;
- (D) COUNTY SCHOOL DISTRICT STAFF ARE PAID SALARIES COMMENSURATE WITH TRAINING, EXPERIENCE, AND EXPECTATIONS OF THE COUNTY SCHOOL DISTRICT;
- (E) STAFF IS SUPERVISED AND EVALUATED;
- (F) COUNTY SUPERINTENDENT ACT AS TREASURER OF THE COUNTY BOARD OF EDUCATION, UNLESS THE COUNTY BOARD HAS TAKEN ACTION TO BECOME ITS OWN FISCAL AGENT IN ACCORDANCE WITH SECTIONS 135.01 AND 3313.22 OF THE REVISED CODE;
- (G) COUNTY SUPERINTENDENT SERVE AS EXECUTIVE OFFICER OF THE COUNTY BOARD OF EDUCATION AND MAY SERVE AS TREASURER OF A JOINT VOCATIONAL SCHOOL DISTRICT IN ACCORDANCE WITH SECTION 3311.19 OF THE REVISED CODE; AND
- (H) COUNTY SUPERINTENDENT SERVE AS THE CHIEF SCHOOL ADMINISTRATOR OF THE COUNTY SCHOOL DISTRICT.

3301-38-13 COUNTY SCHOOL DISTRICT EVALUATION.

- (A) THE EVALUATION PROCESS SHOULD BE AN EXPERIENCE LEADING TO IMPROVEMENTS IN THE SERVICES OFFERED BY THE COUNTY SCHOOL DISTRICT AND SHALL BE CONDUCTED ONCE EVERY FIVE YEARS BY THE OHIO DEPARTMENT OF EDUCATION.
- (B) THE EVALUATION PROGRAM SHALL CONSIST OF THREE MAJOR COMPONENTS;
 - (1) PREEVALUATION CONFERENCE;
 - (2) ON-SITE EVALUATION; AND
 - (3) POSTEVALUATION ACTIVITIES.
- (C) A REPORT OF THE EVALUATION SHALL BE PREPARED AND SHALL INCLUDE A PHYSICAL FACILITIES REPORT AND A SUMMARY OF RECOMMENDATIONS. THE SUPERINTENDENT OF THE COUNTY SCHOOL DISTRICT SHALL HOLD A PUBLIC MEETING WITHIN THIRTY DAYS OF THE RECEIPT OF THE EVALUATION REPORT TO DISCUSS THE RESULTS OF THE EVALUATION. THE COUNTY SUPERINTENDENT IS RESPONSIBLE FOR NOTIFYING THE OHIO DEPARTMENT OF EDUCATION OF THE DATE ON WHICH THE PUBLIC MEETING WILL BE HELD.
- (D) IT IS THE RESPONSIBILITY OF THE COUNTY SUPERINTENDENT TO SUBMIT A PLAN, INCLUDING A TIME LINE, TO THE OHIO DEPARTMENT OF EDUCATION FOR CORRECTING ANY VIOLATIONS SPECIFIED IN THE EVALUATION REPORT. THE PLAN MUST BE SUBMITTED WITHIN NINETY DAYS OF RECEIPT OF THE EVALUATION REPORT. THE TIME LINE FOR CORRECTIONS INDICATED IN THE PLAN MUST BE CONSISTENT WITH THE DATE ESTABLISHED IN THE EVALUATION REPORT OR CONSISTENT WITH THE NEW DATE APPROVED BY THE OHIO DEPARTMENT OF EDUCATION.
- (E) EVIDENCE OF THE IMPLEMENTATION OF THE MISSION POLICY STATEMENT SHALL BE MAINTAINED.

EACH COUNTY BOARD OF EDUCATION SHALL, WITHIN ONE HUNDRED EIGHTY DAYS OF THE EFFECTIVE DATE OF THE RULES IN THIS CHAPTER, SUBMIT TO THE STATE BOARD OF EDUCATION A PLAN OF SERVICE THAT MEETS SAID RULES. THE STATE BOARD OF EDUCATION SHALL, UPON THE APPROVAL OF ANY SUCH PLAN, ISSUE A CHARTER TO THAT COUNTY SCHOOL DISTRICT.
